INTRODUCTION

In December 2006, the City of Visalia, California engaged the team of EDAW, Inc, Provost & Pritchard, and Moffatt & Nichol as the consultant team for the development of the Parks and Infrastructure Master Plan for a 175 acre area known as the East Downtown Visalia district.

Per the East Downtown Visalia Strategic Plan 2025 (2006), this area of Visalia is envisioned as a new residential and mixed-use redevelopment area that would include more than 15 acres of new parks, multiple commercial and institutional opportunities, and a new world-class Civic Center complex.

The purpose of the East Downtown Visalia Parks and Infrastructure Master Plan (the Plan) is to provide a comprehensive strategy and design concept for the landscape and infrastructure for the future Civic Center complex and adjacent land uses. The recommendations and ideas described in this report represent the efforts of many committed individuals from the City of Visalia, the East Downtown Visalia Task Force, the Coordination Group, community members and other stakeholders who actively participated and provided input to the consultant team during the year-long process.

Following the master planning process, the document is organized in four sections describing the main steps undertaken:

- 1) Background and Foundation: a comprehensive site analysis, understanding of relevant plans and policies, and a summary of initial community input.
- 2) Visioning: preparation of two concept scenarios to test ideas and potential approaches for the study area.
- 3) Master Plan: refinement of the visioning scenarios into a preferred alternative including parks, streetscape and infrastructure strategies and design recommendations.
- 4) Phasing and Implementation Approach: preliminary strategy for the potential implementation of the Plan, including order of magnitude cost estimates.

As part of this Master Plan, a series of reports and memoranda were prepared to provide needed detail on the technical aspects of park design and infrastructure planning. Those supporting documents are included in the Appendix section of the document.
