Details: On 8/28/2011 at 0015 hours;
Patrol Officers responded to assist Visalia Fire on a structure fire at an apartment complex in the 500 block of S. Encina. Officers assisted in evacuating the complex, and the fire was quickly contained by Visalia Fire Department. Information was obtained during the initial investigation that the fire may have been intentionally set by S/Owsley in the victim's bedroom. Fire Arson Investigators were contacted and conducted an investigation. The fire was contained largely to the bedroom of one downstairs unit, however; several other units sustained some damage. S/Owsley was contacted by Fire Arson Investigators returning to the scene and was arrested by assisting Officers. S/Owsley was transported and booked at Tulare County Main Jail for Arson. No injuries were reported.
