5. PUBLIC HEARING – Josh McDonnell- *Continued from July 10, 2014*
City of Visalia General Plan Update: The City of Visalia is updating its General Plan, the policy document that guides future growth and development in the City. The State of California requires every city and county to have a comprehensive general plan, identifying current and future needs and establishing policy direction for the areas of land use, housing, transportation, open space, conservation, safety, and noise. Visalia's General Plan also covers issues of infrastructure, growth management, air quality and greenhouse gases, community facilities and utilities, and historic preservation. The purpose of this project is to update the existing General Plan to accommodate and guide growth and development through 2030. A Climate Action Plan has also been prepared to assist with enhancing and developing actions designed to reduce the City's greenhouse gas emissions. A Programmatic Environmental Impact

Report and Statement of Overriding Considerations will be considered that addresses the environmental effects of the new General Plan and Climate Action Plan.

The Planning Commission will be requested to consider the following:

- a) A resolution recommending certification of the Final Environmental Impact Report for the new General Plan for the City of Visalia, adopting Findings of Fact, and adopting Statement of Overriding Considerations as required by the California Environmental Quality Act
- b) A resolution recommending adoption of the Visalia General Plan
- c) A resolution recommending adoption of the Visalia Climate Action Plan
