This application is for **NEW PERMIT APPLICATIONS ONLY** and is not to be used for renewals.

Mail this completed application along with your check or money order payable to the Visalia Police Department; or come in person to pay with a Visa, MasterCard, cash, check, or money order between the hours of 8:00 a.m. and 5:00 p.m. Monday to Friday (excluding holidays) at the following location:

Permit fees are: **\$17.40 a year**, based on the fiscal year of July 1<sup>st</sup> through June 30<sup>th</sup>. The City does not pro-rate these fees.

If you want to contest an alarm response, you must do so in writing to the address listed above within five (5) working days.

# **ALARM PERMITS**

All alarm systems within City of Visalia limits must have a valid alarm permit per Visalia Municipal Code Section 8.08. Alarm permits are renewable on July 1<sup>st</sup> of each year. Failure to renew this permit prior to July 1<sup>st</sup> of each year will constitute a violation.

Alarm permits are issued on an annual basis for a twelve-month period beginning July 1<sup>st</sup> of each year and expiring June 30<sup>th</sup> of the following year. The City does not pro-rate these fees.

Whenever an alarm user desires to test, repair, modify, or install an alarm system, notification of such intentions shall be given to the Visalia Communications Office Dispatcher at 559-713-8116 prior to such actions.

An alarm system shall be supplied with an uninterruptible power supply in such a manner that the failure or interruption of normal utility electricity will not activate the alarm system. The power supply must be capable of at least four (4) hours of operation.

No person shall use or install any alarm, which will initiate a call and deliver a recorded message to any telephone number terminating at the Visalia Police Department.

A service charge for an emergency response will be assessed against a person or business whose alarm system generates false alarms in accordance with the following schedule:

## **POLICE DEPARTMENT RESPONSE**

First response occurring between July 1 & June 30	Free
Second response occurring between July 1 & June 30	\$35.00 each
Third response occurring between July 1 & June 30	\$50.00 each
Fourth response occurring between July 1 & June 30	<u>\$</u> 65.00 each
Fifth response occurring between July 1 & June 30	\$75.00 each
Sixth response occurring between July 1 & June 30	\$90.00 each
Seventh (& any additional) response occurring between July 1 & June 30	\$100.00 each
Replacement of Permit or Validation Sticker	\$4.00 each

All false alarms occurring at locations without a valid alarm system permit and after reasonable efforts of obtaining a permit application have been attained, will be issued an Administrative Citation as required by Visalia Municipal Code Section 1.13.050 with fines starting at \$100.00 for the first violation, \$200.00 for the second violation and \$500.00 for the third and any subsequent violation(s) of the year. Issuance of an Administrative Citation does not eliminate the fact that a permit must still be obtained.
