6. PUBLIC HEARING – Cristobal Carrillo, Associate Planner

a. Annexation No. 2020-02: A request by TMT, LLC to annex a 38.5 acre portion of a 99.27-acre parcel into the City Limits of Visalia, and to detach from Tulare County Service Area No. 1. Upon annexation, the 38.5 acre site will be zoned C-R (Regional Commercial), which is consistent with the General Plan Land Use Designation of Regional Commercial. The project site is located on the southeast corner of W. Visalia Parkway and S. Mooney Boulevard (APN: 126-080-025, 056). An Initial Study was prepared for the tentative subdivision map consistent with CEQA. Initial

Study No. 2020-64 disclosed that environmental impacts are determined to be not significant. The Environmental Impact Report prepared for the City of Visalia General Plan was certified by Resolution No. 2014-37, adopted on October 14, 2014. The Environmental Impact Report adequately analyzed and addressed the proposed project.

- b. Tentative Parcel Map No. 2020-08: A request by TMT, LLC to subdivide a 99.27-acre parcel into one parcel and a remainder for commercial and right-of-way use, located within the C-R (Regional Commercial) zone. According to the City of Visalia Zoning Ordinance Section 17.02.145 and Subdivision Ordinance Section 16.04.040, an appeal to the City Council may be submitted within ten days following the date of a decision by the Planning Commission. An appeal form with applicable fees shall be filed with the City Clerk at 220 N. Santa Fe, Visalia, CA 93291. The appeal shall specify errors or abuses of discretion by the Planning Commission, or decisions not supported by the evidence in the record.
