



The City of Visalia offers financial assistance for Valley Oak (*quercus lobata*) Tree pruning or removal for low-income homeowners that meet income qualifications based on household size. The property where the tree resides must be your primary residence and you must own the home.

#### GUIDELINES FOR SEEKING ASSISTANCE:

1. Tree must be located on a private, residential lot.
2. Submit Intent to Prune Form or Removal Application to the Urban Forestry Division.
3. Submit an application for assistance for oak tree care.  
Application will include:
  - a. Assistance for Oak Tree Form
  - b. Proof of Income (previous year's taxable income documents)
  - c. Proof of ownership
  - d. Intent to Prune Form, or the Oak Tree Removal Form
4. The supervisor, or his representative, will make an on-site inspection of the tree to be pruned to determine the extent of work necessary.
5. The supervisor or his representative will then agree upon a price for the tree pruning or tree removal with a Tree Maintenance Company that is under contract with the city.
6. If the entire cost of trimming was not covered based on the most recent HUD income limits the property owner will be responsible for the remaining percentage
