1. Welcome and Public Comment.

This is a time set aside for the Committee to receive public comment on issues which are not already included on the agenda. Public comment regarding items on the agenda may be open to public comment prior to the committee's discussion of the agenda item and before any action is taken on the agenda item. Members ask that comments are kept brief and positive. In fairness to all who wish to speak, each speaker will be allowed three minutes. Please begin your comments by stating your name and the street you live on.

- Don Sharp welcomed those in attendance.
- City Staff member Allison Mackey noted that anyone who would like Spanish language translation could still receive the equipment from our interpreter in attendance and the meeting could take a few moments for anyone to be set-up.
- There was no public comment.

2. "City of Visalia Introduction to Redistricting" Presentation from Jeff Tilton, National Demographics Corporation

- PowerPoint presentation with accompanying narration provided by Jeff Tilton, in-person, attached.
- Vincent Salinas asked if the districts would remain as they are now, Jeff said that seldom the Census data is similar enough for districts to remain exactly the same.
- Berkley Johnson asked how the City of Visalia got the current districts and Brad Maaske answered, providing information on the City's previous process, with Vincent Salinas adding information.
- Brad Maaske and Vincent Salinas discussed population distribution and what the 2020 Census data could potentially show.
- Don Sharp noted that the law is really specific and briefly discussed the Fair Maps Act, noting that the City Council will vote to adopt a specific map.

- It was noted that there is not a legal definition of communities of interest.
- Rick Feder noted that this was an important that the group provide feedback.
- Brad Maaske said that voters and non-voters/non-citizens are weighted the same by the Census.

3. Discussion on the City of Visalia Public Outreach Plan for City Council Redistricting 2021-2022

- City staff member Allison Mackey discussed the Public Outreach Plan and reviewed the different sections of the plan.
- The Oversight Board noted that NextDoor is a popular in Visalia and that we should use common tools recommended to us by NDC.
- They suggested that we stream future public hearings and it was noted that those will be streamed, as all City Council streams all meetings and our new system retains the video. They also suggested that we try to be guests on local podcasts, reach out to Visalia Unified School District and College of the Sequoias, connect with neighborhood watch groups and place information with local Chambers of Commerce.
- The Oversight Board further suggested we provide information to Neighborhood Church and local, faith-based organizations.
- They had no revisions or suggestions on the material presented in the plan as presented.

4. Future meetings and items for discussion.

- Brad Maaske said he would like to make more suggestions and that the Oversight Board should work on maps, review them and make recommendations to the City Council.
- There was no group consensus on Brad Maaske's comments, Vincent Salinas echoed that the Oversight Board should be more involved in the process than as an oversight committee.
- Don Sharp said that the group had too much knowledge and experience to just be "cheerleaders" for the process, that they were more valuable than just community ambassadors to share information the process and explain to community members the need for public feedback.
- Janice Avila said that she appreciated the City Council seeking the input and experience of the Oversight Board and that she felt they could be good ambassadors for sharing information on the process to the community.
- Several group members asked why the districts needed to be changed at all, and City Attorney Alex Peltzer provided an explainer on why and how the district lines will most likely be affected by the 2020 Census results and that other cities and government organizations were following the same, if not similar, processes.
- Brad Maaske said that he thinks the Oversight Board should be the City's official redistricting committee and be enabled to review maps, provide recommendations and choose a map. He asked how this could happen, to which City Attorney Alex Peltzer said that we would need to present that to the City Council.
- City staff member Allison Mackey asked if the group wanted to formally vote on seeking the distinction Brad Maaske was asking for and asked if there were any motions. There were none and no Oversight Board member provided a reply.
- City staff member Allison Mackey noted that the next public hearing would be on 9/20/21 during the City Council meeting. Several board members asked if they

1. Federal Laws

- Equal Population
- Federal Voting Rights Act
- No Racial Gerrymandering



2. California Criteria for Cities

1. Geographically contiguous
2. Undivided neighborhoods and “communities of interest”
(Socio-economic geographic areas that should be kept together)
3. Easily identifiable boundaries
4. Compact
(Do not bypass one group of people to get to a more distant group of people)

3. Other Traditional Redistricting Principles

- Minimize voters shifted to different election years
- Respect voters’ choices / continuity in office
- Future population growth
- Preserving the core of existing districts

Prohibited: “Shall not favor or discriminate against a political party.”

- Areas around parks or schools
- Other neighborhood landmarks

In the absence of public testimony, planning records and other similar documents may provide definition.

- Or would it benefit more from having multiple representatives?

Definitions of Communities of Interest may not include relationships with political parties, incumbents, or political candidates.

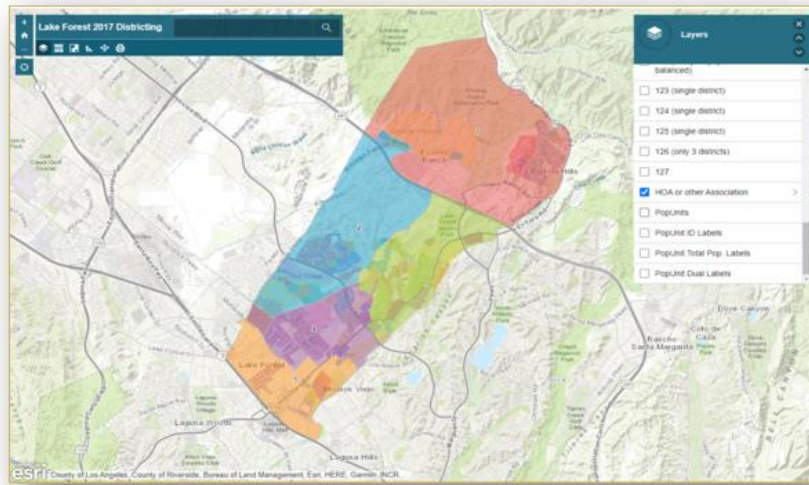

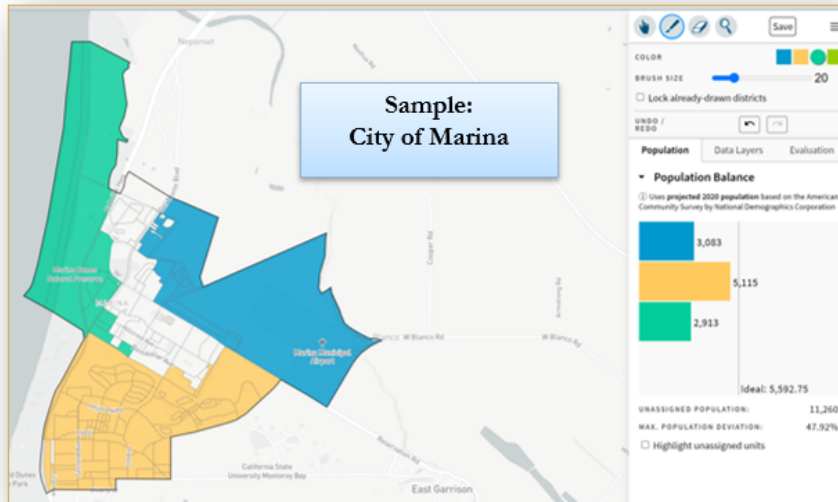

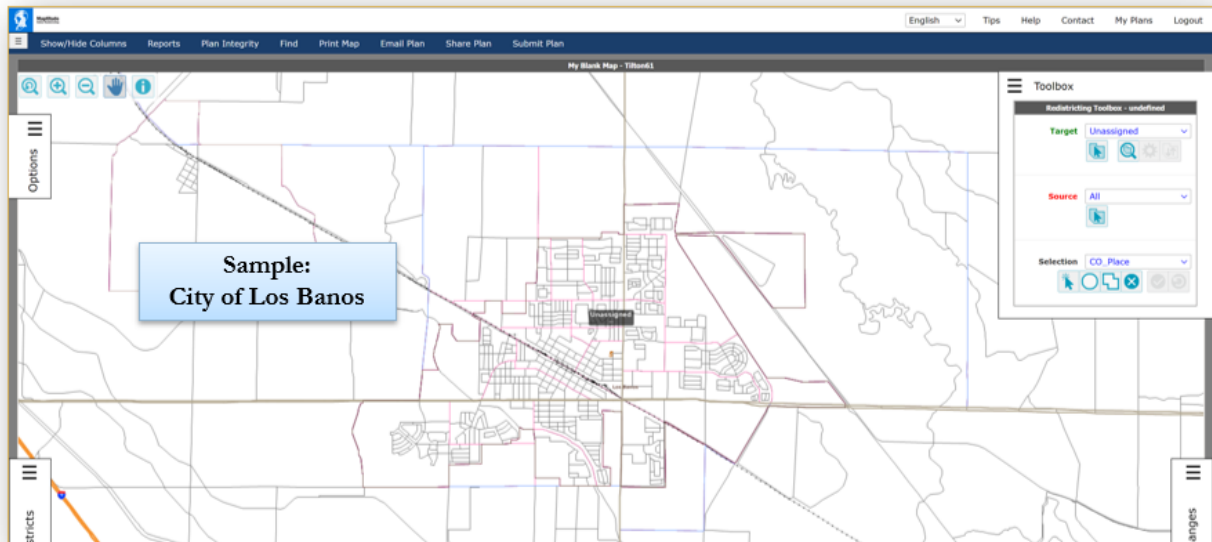

 - The finalized maps that you will help us create will define the City of Visalia district borders, and these new districts will impact how you elect your council members for the next 10 years.
 - Our primary goal when developing election districts is to draw lines that respect neighborhoods, history and geographical elements.
 - We want to know: What do you consider the boundaries of your neighborhood?
