5. Commission Requests and Comments:

- Commissioner Hawkins said that there is lots of trash on the Millcreek Trail, Lovers Lane to McAuliff Street
 - Alvin Dias said that the City is currently negotiating cost with ABLE Industries to increase service. Looking at possibility of additional City staff to perform in-house maintenance. The City HOPE Team, Code Enforcement, and other entities are involved to try to clean up the area
 - Visalia Police Department and Tulare County Sheriff Department performed a detail at the St. John's trail to reduce the number of illegally operated vehicles
- Commissioner Wagner asked for a recruitment update for the Parks & Recreation Director position

- Commissioner Hickey asked for an update on the Anthony Community Center electrical panel repair.
