Historic Preservation Advisory Committee Goals 2022 – 2024

1. Survey

- a. Survey properties that are within the Historic District, but not on the Local Register.
- b. Identify sites outside of the Historic District for possible Local Register designation (Consult with Terry Omen for guidance).
- c. Review and survey mid-century structures for Local Register designation.
- d. Re-list relocated Local Register properties.
- e. Research protecting local landmarks.
- f. Identify sites for nomination to California/National historic registers.
- g. Expand the Historic District (South Locust Street corridor).

2. Technology

- Develop a searchable/interactive historic database for staff and public use.
 Database can be updated with surveys, photos, architectural information,
 Historic District/Local Register designations (Timing/Staff availability information required from City Staff).
- b. Develop a survey app for phones

3. Homeowners Incentives

- a. Re-establish plaque and awards programs.
- b. Research incentives and grants for property owners.
- c. Establish a recognition system/list for historic signage (Visalia Tea Garden neon sign, etc.).

4. Marketing and Community Outreach

- a. Reach out to the Tulare County Association of Realtors to inform brokers of the HPAC.
- b. Set up HPAC information booths at public events volunteer engagement.
- c. Build a network of community volunteers, and build a list of prospective HPAC members.
- d. Network with other community groups (Downtown Visalia's, Visit Visalia, Lions, Rotary, Soroptimist, Kiwanis, etc).
- e. Create a newsletter and continue community outreach through meetings and events.

5. Historic Preservation Guides

- a. Refine architectural style descriptors in the Local Register to help identify architectural styles more easily.
- b. Draft designs guidelines for fencing/ historic buildings.
- c. Create a workbook resource for use by property owners for the restoration of historic structures.

6. Financial

a. Investigate/apply for the Certified Local Government program.

Dear Mayor Poochigian:

I write to notify you that on September 5, 2024, the above-named property was placed in the National Register of Historic Places (National Register). As a result of being placed in the National Register, this property has also been listed in the California Register of Historical Resources, pursuant to Section 4851(a)(2) of the Public Resources Code.

Placement on the National Register affords a property the honor of inclusion in the nation's official list of cultural resources worthy of preservation and provides a degree of protection from adverse effects resulting from federally funded or licensed projects. Registration provides several incentives for preservation of historic properties, including special building codes to facilitate the restoration of historic structures, and certain tax advantages.

There are no restrictions placed upon a private property owner regarding normal use, maintenance, or sale of a property listed in the National Register. However, a project that may cause substantial adverse changes in the significance of a registered property may require compliance with local ordinances or the California Environmental Quality Act. In addition, registered properties damaged due to a natural disaster may be subject to the provisions of Section 5028 of the Public Resources Code regarding demolition or significant alterations if imminent threat to life safety does not exist.
