

## ***W. Acequia Parking Structure***

### ***Reserved Parking Space Permits***

#### **General Information and Terms of Use**

1. Purchasing and properly displaying a valid City of Visalia Reserved Parking Permit for the **W. Acequia Parking Structure (222 W. Acequia)** in Downtown Visalia allows you to park Monday – Friday between the hours of 7:00 a.m. and 6:00 p.m. in a **designated parking space** which you purchase (3 month minimum) in the Parking Structure.
2. See attached map for information showing designated “permit parking” spaces. Not all spaces are currently available. A current list is available upon request but could vary from day to day depending on permit activity.
3. **Designated parking spaces are marked "Reserved" and the permit number must coincide with the assigned parking space number.** Vehicles displaying a valid W. Acequia Parking Structure Parking Permit may park in the assigned space at any time during the period purchased. Expiration dates appear on the permit per Visalia Municipal Code Sec. 10.16.145; Ord. No. 2000-10
4. W. Acequia Parking Structure Permits are not valid for use on any streets, in any other parking structure , public lots, or any parking spaces designated for handicap, hotel, city, senior or private uses.
5. To properly display a parking permit:
6. The hang tag must be hooked over the rearview mirror support bracket whenever the vehicle is parked in the assigned space at 222 W. Acequia.
7. Note – Do not operate a vehicle while a hang tag is on the rearview mirror. This could result in a traffic hazard.
8. The permit displayed must contain the current permit expiration date.
9. Valid parking permits for W. Acequia Parking Structure (222 W. Acequia) can only be purchased from the City of Visalia, 315 E. Acequia, Visalia, CA 93291. Contact (559) 713-4414 or EPO@visalia.city
10. The cost of a W. Acequia Parking Structure permit is **\$25.00 per month** for a **minimum time period of 3 months**, not to exceed one year, per parking space. (See attached map for parking space availability). Upon expiration of a parking space permit, the current permit holder shall have first preference to renew the particular parking space providing it is renewed before the expiration date.
11. Permits purchased during any given month may be purchased on a prorated basis if purchasing the next 3 month period.
12. A lost or stolen permit should be reported immediately.
13. **Replacement permits can be purchased for \$10.00 each with proof of identity.**
14. Parking permits are enforced by the Visalia Police Department. Any tickets received or complaints regarding tickets must be directed to the Visalia Police Department.
15. Refunds cannot be issued for any portion of an unused permit.
